

**TOWN OF BARNES ORDINANCE NUMBER CHAPTER 5-7a
AMENDMENT TO CHAPTER FIVE OF THE TOWN OF BARNES ORDINANCES**

The town board of the Town of Barnes, Bayfield County, Wisconsin, adopted on proper notice with a quorum and by a roll call vote of a majority of the town board present and voting resolves and orders as follows:

Chapter five (5), section 5-7(a) of the Town of Barnes ordinances shall be amended to read as follows:

- (a) Unless otherwise indicated within the Code of Ordinances, the schedule of deposits as indicated below shall be made in cash, money order or certified check to the Clerk of Circuit Court, Bayfield County, who shall provide a receipt therefore.
